

## **WEBSITE TERMS OF USE**

### **1. Terms of Website and Mobile Application Use**

### **2. Information About Us**

Our sites are operated by Saint-Gobain Construction Products UK Limited trading as International Timber ("We"). We are registered in [England and Wales] under company number 00734396 and we have our registered office at Saint-Gobain House, East Leake, Loughborough, Leicestershire, LE12 6JU.

### **3. Accessing Our Site**

Access to our site is permitted on a temporary basis, and we reserve the right to withdraw or amend the service we provide on our site without notice (see below). We will not be liable if for any reason our site is unavailable at any time or for any period.

From time to time, we may restrict access to some parts of our site, or our entire site, to users who have registered with us.

If you choose, or you are provided with, a user identification code, password or any other piece of information as part of our security procedures, you must treat such information as confidential, and you must not disclose it to any third party. We have the right to disable any user identification code or password, whether chosen by you or allocated by us, at any time, if in our opinion you have failed to comply with any of the provisions of these terms of use.
